

April confirms cargo recovery

A positive month registered the Port Area of Barranquilla, where there was a growth of 17% compared to April of the previous year, when the impact of COVID had yet to hit cargo flows. Although the insights where lower than last March, a very good dynamics of imports in bulk stands out, which could be higher if the restrictions that forced the draft to be lowered to 9.0 meters were not present, while coke exports continues at a high level. The movement of liquid cargo also presented the highest figure of the last year.

In the Year-to-date figures, although there is a decrease of 3% compared to the same period of the previous year, if we compare only the number of imports plus exports, the accumulated is similar to the previous year.

During the month of April there were deteriorating conditions in the navigable channel, which caused the maritime authority to restrict the draft to 9.0 meters. This is partly since there has been no continuity in the dredging maintenance one, since in two occasions the processes to contract this dredging were declared void, as no company presented offers. In any case, it is expected that in the first days of May, the dredger Bartolomeu Dias will return to work in the port area to recover the areas where the greatest sedimentation has occurred. In parallel, the state entities have been working on achieving the permanent dredge until December of this year.
